

Previously the Dartmoor Pony Society of America

DNA typing of the sire, dam, and foal is required through the University of Kentucky for a foal to be registered. The procedure is to send a DNA Testing form with the hair sample and check to the registrar. The Registrar then sends the sample to UK and they return a report to the registrar. If requested, a copy of that report is sent to the owner of the pony. The registrar can only send the report to the pony's owner. The sire and dam of a foal must have been DNA typed through the University of Kentucky for that foal to be registered in the DPRA studbook. **Five photos of the pony are required with the application. Instructions are below.**
